I am directed to refer to your letter No.MCI-34(41)(R-6)/2014-Med./151277 dated 21.01.2015, read with your previous letters MCI-No.34(41)(R-6)/2014-Med./128908 dated 3.9.2014 and MCI-No.34(41)(R-6)/2014-Med./114780 dated 14.06.2014, on the subject noted above and to say that the Ministry has examined the Council's recommendations contained therein in the background of the Council's May, 2014 Assessment Report of the college, the Supreme Court Order dated 18.9.2014 allowing renewals to all medical colleges for the academic year 2014-15, whose renewal schemes had been disapproved earlier, and the recommendations of two Hearing Committees constituted by the Ministry during 2014-15 and 2015-16 under the provisions of section 10A(4) of the IMC Act for the same sets of deficiencies and same aforesaid Assessment Report of the MCI, and to say that no inspection has been carried out by the MCI since May, 2014. This in any case should have been done on the basis of Supreme Court Orders dated 18.9.2014 to verify the Undertakings given by the College to Supreme Court. The Council has merely taken a technical view that as its inspection dated 27-28th May, 2014 identified gaps in faculty and residents, they will not inspect the college again.

- 2. The Council's aforesaid letters are about the proposal for renewal permissions to the college for the academic year 2014-15 only, whereas the college has already been allowed renewal for the year 2014-15 by the Supreme Court through its aforesaid Order dated 18.9.2014. Hence the academic year under consideration / reference should be 2015-16 only. The Council and the Ministry are already presently engaged in respect of various Under Graduate proposals for the academic year 2015-16 itself.
- 3. In view of the above, the Council is hereby directed to conduct fresh inspections of the college and submit its report to the Ministry accordingly.
