As per the permission accorded in the MCI-No. 34(41)/2012-Med./112845 dt: 21-06-2012 of the Deputy Secretary, Board of Governors in Super-session of Medical Council of India, New Delhi and as per the orders of the Vice-Chancellor, Dr. NTR University of Health Sciences vide 8<sup>th</sup> cited and as per the statutes on affiliation of Medical colleges of Dr. NTR University of Health Sciences, Vijayawada, it is hereby certified that the application of Chandramma Educational Society, Secunderabad has been registered with the Dr. NTR University of Health Sciences, Vijayawada Provisional affiliation is granted for starting of 1<sup>st</sup> year MBBS Course for the academic year 2012-13 and permitted to make admissions at Malla Reddy Institute of Medical Sciences, Qutbullapur, R.R Dist., with an intake of 150 students (One Hundred Fifty only) for the academic year 2012-13 as per rules.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Medical Council of India / Dr. NTR UHS.

The fee collected by what so ever name called either for University quota seats or for management seats should not exceed the limits specified by the Government of Andhra Pradesh/Dr. NTR UHS from time to time.


The Management of the college shall follow the regulations made by the University/Government of Andhra Pradesh and also the Graduate Medical Education Regulations 1997 of the Medical Council of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice.
