

Memorandum of Understanding

This Memorandum of Understanding (MoU) is made on 25th day of February 2020 at Malla Reddy Institute of Medical Sciences, Sy No. 138, Suraram Main Road, GHMC Quthbullapur, Jeedimetla, Hyderabad – 500 055

BETWEEN

Ibrum Technologies (OPC) Private Limited incorporated under the Companies Act, 2013 , with its office at NASSCOM CoE IoT, #150, Lower Basement, Central Atrium, DD4, Diamond District, Kodihali, Old Airport Road, Bangalore- 560008 (hereinafter called 'IBRUM TECHNOLOGIES' which expression shall, where the context so admits, include its successors and permitted assigns) of the first party.

AND

Malla Reddy Institute of Medical Sciences (sponsored by Chandamma Education Society) having its office at Malla Reddy Institute of Medical Sciences, Sy No. 138, Suraram Main Road, GHMC Quthbullapur, Jeedimetla, Hyderabad – 500 055 (hereinafter called "MRIMS" which expression shall, where the context so admits, include its successors and permitted assigns) of the second party,

Preamble:

IBRUM TECHNOLOGIES is a science and technology company, supported by Startup Karnataka with primary focus on design and development of novel medical devices for public health and involved in the research and innovation for the proper understanding of clinical needs and product design.

MRIMS is a medical college and hospital, with health care facilities and desire to promote research and innovation activities among the students, interns and faculty of the institute.

IBRUM TECHNOLOGIES is working on a novel medical device to assist clinicians and paramedical staffs to screen people with symptoms of respiratory disorder like

pneumonia, COPD and asthma. As a part of the research, there is a need to observe the patients, collect physiological parameters from patients and take the inputs of the clinicians (end user feedback) and hence desires to do clinical validation study at MRIMS.

Scope of Work and Responsibilities:

- 1) **IBRUM TECHNOLOGIES** will conduct the clinical studies and device validation in MRIMS campus and involve Intern from MRIMS as the “research intern”.
- 2) **IBRUM TECHNOLOGIES** will provide the Internship Certificate and suitable remuneration for the participating interns for the research as per the involvement in research (as part of industry academia collaboration)
- 3) **IBRUM TECHNOLOGIES** will provide all the necessary instruments and accessories for the conduct of the studies.
- 4) **MRIMS** will provide necessary infrastructure and place to conduct the study.
- 5) **MRIMS** will allow to record the feedback from clinicians (written, audio and video format) for the purpose of study.

Confidentiality

Both parties hereunder agree that any information disclosed by one party to the other shall be maintained as proprietary confidential information and will be disclosed only to the authorities as required in the relevant statutory regulations and to those persons in the recipient party's organization that has a need to know for purposes authorized by the relevant agreement. All such proprietary confidential information will be kept in confidence and the party receiving the confidential information agrees not to disclose to any other person or persons outside the organization or any unauthorized person or persons except to the organization authorized by either of the parties hereunder on need to know the basis for the execution of the work.

Publication

Publications, if any, in respect of the activity under this MoU shall be in the names of involved personnel from both the parties. The authorship order should be given according to preference of the work done and its importance to that outcome. In all publications (papers, reports, etc.) it will be duly acknowledged that the work has been carried out by/in MRIMS and IBRUM TECHNOLOGIES under this MoU between the parties.

Duration

This Memorandum of Understanding shall be valid for a period of one year from the date of signing of the same and thereafter can be renewed for further periods subject to such other terms and conditions as may be mutually agreed upon.

Termination

Either of the participating parties may terminate this MoU by giving one months' notice in writing to the other party. Either of the parties shall honor within a mutually agreed period, the outstanding commitments, if any, as on the date of termination.
