
arise. Besides, National Medical Commission (NMC) is entitled to take all such measure against you and your college/institution as permissible under the law.

It is mandatory for the Government Medical colleges to contribute 15% of MBBS seats and 50% of Post Graduate Broad Specialities (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of the Supreme Courts.

It is mandatory to develop a website on the medical college/institution and display all the information of the college, courses offered, faculty available and their experience of the last 5 years, students joined, and affiliating university. To display the hospital services, facilities available and the equipment in each speciality, also showing OP and IP census including births and deaths as per the municipal/Govt. records.
